BOY IN SALK TEST GETS POLIO

Port Huron, Aug. 21.—Timothy, seven year old son of Mr. and Mrs. George Agajeenian, 3311 Conger St., is the first child in the Salk vaccine program in St. Clair County to be stricken with the disease.

Timothy received all three shots that were given in the vaccine test and was admitted to Port Huron hospital August 9th.

Second Tulsa Child Succumbs To Polio
Tulsa, May 29.—Patricia Reddick, 8 year old Tulsa second grade pupil, died late last night of polio to become the second victim of the disease here this year. Her parents, Mr. and Mrs. Earl Reddick, said Patricia was among the Tulsa County second graders in the polio vaccine trials. Dr. T. P. Haney, health director said "some deaths will occur whether the vaccine has been used or not."

GIRL TAKES POLIO AFTER VACCINATION
Houston, Texas.—A seven-year-old girl who took all three shots of the Salk polio vaccine was stricken Friday with polio and admitted to Hedgecroft Clinic. Jeannette is the daughter of Mr. and Mrs. Elton Kirchenwitz. A spinal fluid test taken showed Friday she was suffering from polio.

SALK TESTER, 8, GETS BULBAR POLIO
Bradford, Pa., Sept. 10.—Dr. H. J. McGhee, McKean County Health Director, reported today that a second grader who was inoculated with the Salk vaccine is a victim of bulbar-type polio. Eight-year-old Terry F. Tessena, of Smethport, is in Bradford Hospital in serious condition and has been in an oxygen tent for two days. Bulbar polio is the most serious type.

Shot Recipient Admitted Here As Polio Case
Oklahoma.—Larry Euler, 8, of 1039 N. Delaware Ave., who, according to hospital attendants, received all three of the shots of Salk vaccine last spring, was admitted to the polio division at Hillcrest Medical Center Thursday. The boy, son of Mr. and Mrs. Luther Euler, was placed in an iron lung, after a tracheotomy was performed to facilitate his breathing. Oklahoma State officials report 3 other children contracted polio following their participation in Salk vaccine tests.

VACCINE TEST SUBJECT HERE IS STRICKEN
Dayton, Ohio, July 21.—Stricken with acute poliomyelitis is an 8-year-old boy residing in the 1100 block of Highland Ave., East Dayton. The boy is the first in the Ohio test group to get polio. A national report Friday said several inoculated children are reported to have become polio victims.

Vaccinated Boy Stricken
Syracuse—(AP)—The city health commissioner reported yesterday that a youngster who was inoculated in recent polio nation-wide tests of the Salk polio vaccine has been stricken by the disease. Dr. A. C. Silverman has been not known whether the boy received an injection of the serum or of a neutral substance.

POLIO STRIKES BOY WHO WAS IN VACCINE TEST
Peoria, July 7.—Dr. Fred P. Long, Peoria County Health Commissioner, said today a 6 year old suburban Bellevue boy who participated in anti-polio tests this spring now has polio.

INOCULATED CHILD HIT BY POLIO
Pontiac, Mich., June 13.—A second Michigan child who participated in the recent Salk polio vaccine tests has developed polio, and her mother also has been hospitalized for observation. The newly stricken polio patient is Linda Brooks, 7, of Farmington township. She was admitted to hospital June 4.

POLIO HITS TEST CASE
Seattle, June 16.—A King county youngster taking part in polio vaccine tests in Washington state, has contracted the disease, Dr. W. R. Giedt, state epidemiologist, said today.

BOY WITH 'SHOTS' CONTRACTS POLIO
Corpus Christi.—A 7-year-old boy who took the series of Salk polio vaccinations has contracted polio, the city-county health unit reported Monday. He was one of the Corpus Christi second graders who took part in a nation-wide test of the new polio vaccine developed by Dr. Jonas Salk of Pittsburgh. The State Health Dept. said in Austin there had been "one or two" similar cases in Texas.

SALK VACCINE PATIENT GETS POLIO ATTACK
Fort Wayne, Ind., July 28.—The first case of polio among the Indiana children who received the Salk vaccine injections last spring has developed at Fort Wayne. Dr. Walter Kruse, Fort Wayne Board of Health, said the illness of John Erb III, 8, has been diagnosed as polio and he was one of the second grade children given the vaccine injection.

VICTIM OF POLIO HAD RECEIVED SALK VACCINE
Topeka, Aug. 21.—A 7-year-old polio girl who received the Salk vaccine as part of a nation-wide vaccine test is hospitalized here with polio this week. She is Barbara White, daughter of Mr. and Mrs. Woodrow White.

ANY PUBLIC OFFICIAL WHO HESITATES TO STOP THE LICENSING AND USE OF "FAKE" VACCINES IS NOT FIT TO SERVE THE PUBLIC!

SCIENCE IS NO LONGER SCIENCE WHEN IT ATTEMPTS TO VIOLATE GOD'S NATURAL LAWS.

Vaccination for immunity is strictly a *strange, unscientific, mischievous "myth,"* the practice of which makes a body **"unclean"** and subject to sickness which may be **POLIO**.

Scientist and physician, Dr. William F. Koch, M.D., Ph.D., says, "the injection of any serum, vaccine, or even penicillin, has shown a very marked increase in the incidence of POLIO, at least 400%. Statistics on this are so conclusive, no one can deny it."

POLIO is so correctly defined by a famous POLIO authority as . . . **"POLIO IS A TOXIC WASTE PARALYSIS. TOXIC . . . because of how it affects. WASTE . . . because of what it really is. PARALYSIS . . . because of what it does."**

POLIO is **NOT** caused by any live virus or little bug. It is based *most often* on a calcium deficiency, bringing on muscular spasms and spastic conditions in the intestinal tract. Basically, cleansing the intestinal tract is the *secret* to the fast and **COMPLETE RECOVERY** of POLIO patients.

A polio vaccine of any type, is just as worthless in the prevention of polio, as a vaccine would be to prevent a broken ankle or a dented fender on your car. **NO VACCINE HAS OR CAN ACHIEVE ITS INTENDED PURPOSE.** Vaccines have only filled countless cemeteries with innocent victims killed prematurely by **FRAUDULENT** injections.

Sept. 20th, 1953: "The UNITED NATIONS WORLD HEALTH ORGANIZATION COMMITTEE reports, "Effort to control Polio Complete Failure and **condemns** any large scale intra-muscular injections."

Oct. 21st, 1953: Didn't Dr. William M. Hammon, (University of Pittsburgh) discoverer of Gamma Globulin as a polio treatment, say "the new polio vaccine, being developed by Dr. Salk should not be treated with too much optimism."

The "promoters" of this dangerous vaccine give **NO GUARANTEE** or **NO ASSURANCE** that it will not **KILL** your child . . . so . . . **why should you take a chance?**

Jan. 16th, 1954: A former feature-writer for the March of Dimes, came to us and outlined in **detail** the plan for the Salk "carnival" and how they were **protecting** themselves by using half of the children, injected with something else other than the Salk vaccine. **Figure it out for yourself.** They didn't need to inject an equal number of children with **red water.** They could simply have taken the names and addresses of little children. This is the most **asinine** thing that has ever been done in this country; but, as this writer explained to us, **they had to do it** so they could **juggle** any unfavorable results of the vaccine test. No **HONEST** project has ever been protected by a **SECRET CODE**, controlled and known **ONLY** to the "gang" themselves. **Neither HITLER nor STALIN ever dreamt up anything that DOWN-RIGHT ROTTEN.**

TIME Magazine, a while back, stated: "Among one million children vaccinated with the Salk Vaccine, 700 cases of detectable polio would develop; of these, 483 would sooner or later recover completely; 175 would have some permanent paralysis; and, **42 would DIE.**" *That law of averages still apparently stands.*

Feb. 19, 1954: We published the sensational sheet **"FAKE POLIO VACCINE MAY KILL YOUR CHILD,"** which to this day has never been disputed by the March of Dimes "money-grabbers."

March 29, 1954: We published the sensational folder, **"LITTLE WHITE COFFINS,"** in which we point out that one of Dr. Salk's former "instructors" came out with a polio vaccine a few years back, injecting it into innocent little children, many of them **died** and the instructor committed **suicide.** It also pointed out that our State and Federal Health Departments should **prohibit** the use of this **untested, unapproved, unscientific** vaccine, which had not been approved and licensed in compliance with the Federal Laws.

How they got by with using it in 1954, we don't know.

April 4th, 1954: Walter Winchell, *over radio and television, WARNED* the public against the Salk vaccine being a possible **killer.** At that time, our president, Duon H. Miller, gave to Walter Winchell in writing the enclosed challenge:

"I, Duon H. Miller, President of Polio Prevention, Inc., Coral Gables, Florida: hereby offer to personally serve as a 'human guinea-pig' by allowing blood from a new polio patient to be injected **DIRECTLY** into my bloodstream, or if the skeptics prefer they may administer this polio blood to me **ORALLY.**"

Along with this challenge, in writing, was an offer to wager \$10,000.00 by Duon H. Miller that he would not become a victim of Polio, *if the challenge were accepted.* Why haven't the "smart" boys accepted this challenge, or even the challenge of Dr. S. A. Mills who offers to go before television and **PROVE** that Polio is easily successfully treated.

May 21st 1954: A Polio Rally was held at Dayton, Ohio, to which Dr. Jonas Salk was invited, as was Dr. Edward F. McCormick, president of the American Medical Assn., and four other medical men, as well as representatives of POLIO PREVENTION, INC. The latter flew to Dayton, Ohio for the rally but Dr. Salk and the five other "medicos" failed to appear. **Why? ? ?** You know why and so do we. **They didn't want to be exposed.**

Nov. 30th, 1954: In our letter to President Eisenhower, we pointed out the invitation on November 30th, 1954, by Dr. S. A. Mills of Burlington, Kansas who has **100% successful record** in treating polio. *Let us quote this paragraph from our letter to President Eisenhower:* "For example, Mr. Basil O'Connor, president of the Nat'l Foundation was scheduled and did speak in Topeka, Kansas on December 6th, 1954. On November 30th, Dr. Mills of Burlington, Kansas, invited Mr. O'Connor to visit the Mills Clinic at Burlington where they have **100% SUCCESSFUL** record in treating polio. He even offered to pay the expenses of Mr. O'Connor's trip from Topeka to Burlington and back; but, nothing happened. Doesn't this **PROVE** to you that the racketeers are **NOT** interested in the prevention and treatment of Polio?"

There are several clinics in the United States that are **100% SUCCESSFUL** in treating polio, in just a matter of a few days. Yet, the National Foundation is **not** investigating; does **not** cooperate with these marvelous doctors; and, thousands of little children are becoming **CRIPPLES** and **DYING** from Polio, **SO UNNECESSARILY.**

Jan. 25th, 1955: In a letter from Polio Prevention, Inc., to Dr. Jonas Salk, we wrote in part "Will you accept at our expense an invitation to a public forum on **'THE TRUTH ABOUT POLIO???'** All ambiguous **HOLLOW** words and 'mental-convulsions' will be barred . . . only **FACTS** will be dealt with. To this forum why not bring Dr. Sabin, Dr. Van Riper, Basil O'Connor and the President of the American Medical Association?" **To this date, that letter has never been answered, nor the invitation accepted.** In our opinion, *Dr. Salk knows no more about the TRUTH ABOUT POLIO than does your bloodblack.*

Feb. 15th, 1955: Dr. Salk asks for **10,000 little children** to serve as "guinea-pigs" so he can "experiment" and try to ascertain the "dosage required" and the "time between shots." Now, here it is less than a month after Dr. Salk asked for 10,000 little children to experiment with, that they are about to "ballyhoo" this vaccine and report it a **complete success.** **How asinine and criminal to simply "guess" on this entire farce?**

Feb. 22nd, 1955: Our folder **"GOD before GOLD"** says:

LONDON loudly protests "Guinea Pig" treatment of children given "shots" for merely "pseudo-medical" **CURIOSITY**, insisting the parents have **NO LEGAL RIGHT** to authorize "experiments" on children merely that "QUACKS" might compare the "reactions." **IT IS AN INVASION OF THE CHILD'S INALIENABLE RIGHTS,** (actually "vivisection" of children) and is just as **ILLEGAL** in America.

PARIS press **warns** the people against the Salk vaccine and **deplores** its promotion in the States.

The "money-beggars," originators of polio vaccine, and the manufacturers of it (in spite of parents consent) are financially **LIABLE** as parents were **not** acting voluntarily, (in the true sense of the word) . . . rather they were in a **hypnotic state, frightened, brainwashed, intimidated, lied to, and coerced through panic-created FEAR.**

Feb. 24th 1955: An M. D. spoke on polio in Miami, apparently for the March of Dimes. He **ADMITTED** they did **NOT** know the cause . . . had **NO** positive diagnosis and **NO CURE.** **Shouldn't this CONDEMN this Foul-smelling "racket"???**

March 1st, 1955: Let us quote from a national magazine as follows: "The March of Dimes, has an inkling that the Salk vaccine is a "bloody" . . . which it is. His great organization bamboozled the public into believing the tests made last Summer on about 2,000,000 youngsters were open and above board . . . but he was careful to hold the "secret code" secure from the public so that nobody but his own organization knew which children got the blood poisoning vaccine and which got the colored water. So, having all the cards in his possession, his organization can shift them around to make whatever "deductions" necessary to wring more money from the people. But knowing the hoax cannot last forever, the March of Dimes has seven other experts "working" who, when the nod is given them, will come up with "another sure preventative" of polio and the whole dismal drama will be enacted all over again."

No doubt you read the new reports of Dr. Sabin, Cincinnati, working on a **live virus.** He does **not** agree with Dr. Salk's idea of a "killed virus." Maybe that will be the "gimmick" for the "protection" of the March of Dimes money-grabbing racket next year. Then possibly, the year after that, they will be promoting the work of Dr. Murray Saunders, University of Miami, who has been getting publicity on his idea of using a substance made from the snake venom of cobras and rattlesnakes for a vaccine. **Can you imagine injecting such a substance into human bodies or the bodies of innocent little children?**

Polio vaccination is undoubtedly the most harmful preventative treatment ever "foisted" upon humanity. It upsets the body chemistry, is a **disgrace** to civilized people, and a **disgusting, unChristianlike, practice.**

Health and Immunity are **not** created by injecting poisons, drugs and vaccines into our bodies. **IMMUNITY IS A NATURAL CONDITION OF A HEALTHY BODY.** Vaccinated children are **FAR MORE SUSCEPTIBLE** to Polio than children whose bodies have not been so violated.

March 2nd, 1955: The March of Dimes states: "After 1955, we will no longer take part in the production, distribution, and administration of the polio vaccine." They have already raked in their **MILLIONS** and now the Drug Trust can get **RICH.**

March 3rd 1955: The American Medical Assn. advised us, by wire, that they have **NOT** approved the Salk vaccine. Why?? Are they waiting for the **RUSSIAN** doctors (on our Federal payroll) to set the policy and take the lead? **This mess truly STINKS.**

March 12th, 1955: A truly great American writes: "I surely would like to see a congressional investigation of this march of dimes bunch, they need to be placed behind bars to make the world safer for humanity."

Dr. R. H. Bakewell, M.D., reports: "I have very little faith in vaccination even as modifying the disease and **none at all** as a protective in virulent epidemics. I see nothing but an act of **needless cruelty** in inflicting on a perfectly healthy babe an acute febrile disease like vaccination!"

Dr. L. C. Appel, M.D., writes: "The fact that vaccination is either (a) the adding of a disease to a body already weighted with disease, or else (b) the giving of a disease to a perfectly healthy body, is the medical reason why some of us oppose vaccination and urge its abolition. A perfectly healthy body is proof against natural disease, a diseased or unhealthy body is handicapped by being given another (an inoculated) disease. March 14th 1955: Read page 21, in the March 14th issue of the NEWS-WEEK where they comment on the secrecy surrounding the Salk vaccine. The fact that it is protected by a "secret code" is enough to stamp it **FRAUDULENT** in the minds of every clear-thinking American.

March 17th, 1955: The Miami Herald, this morning, reports that the Salk vaccine faces several big "ifs," but they hope to start using it in Miami by April 18th. **Why jeopardize the lives of innocent children with a gang of "ifs"???**

It may not be exactly "out of order" but it was pointed out to us that some of the "doctors" on the federal payroll of the U. S. Public Health Service are on committees of the March of Dimes. **What's your reaction?**
